RURAL WOMEN NEW ZEALAND TERTIARY BURSARY

- 1 This application form must be accompanied by the following:
 - 1.1 A letter, written by the applicant, outlining the reasons for requiring this financial assistance, the reasons for the proposed course of study and the intended use of the qualification.
 - 1.2 A copy of the previous year's study results or the last school report (if within three years); or an academic reference.
 - 1.3 A character reference from a responsible Officer of the Rural Women New Zealand Branch concerning the circumstances of the family and the need for assistance for the applicant's education.
 - 1.4 A character reference from a responsible citizen other than a teacher or member of the Rural Women New Zealand Branch.
 - 1.5 Proof of enrolment at University, Polytechnic or College for a full year's course.

NOTE 1: The above character references may be sent directly by the referee to Rural Women New Zealand, marked **Bursary/Confidential**.

NOTE 2: **If this application is accompanied by an application for either a Rural Women New Zealand Agriculture Tertiary Bursary or a Rural Women New Zealand Text Book/Resource Grant, only one set of supporting documents is required.**
- 2 Applications will be considered by the Bursary Committee of Rural Women New Zealand National Board at the next meeting. The decision of the Committee is final and all candidates will be notified of the results of their application.
- 3 Payment of the Bursary will be made by 31 May to the applicant. Rural Women New Zealand National Office must be advised immediately if the applicant withdraws before completing the academic year, as a proportional refund will be expected.
- 4 The Bursary is payable for one year only.
- 5 Any person meeting the criteria who is a New Zealand citizen is eligible to apply for this Bursary.
- 6 The decision of granting this bursary is final and no discussion will be entered into.
